MARACA Gmail account

Elections – 2025

- Error in Bylaws discovered & needs corrected/amended.
 - Our current Bylaws, Article VI [Election of Officers], Section 2 [Terms of Office] states "Executive Board members will be elected for two-year terms. Elections for all executive board members will occur in odd numbered years" <u>HOWEVER</u> this contradicts Section 3 [Electoral Process] "Elections will be supervised by the Secretary during odd-numbered years and by the Vice President of Membership during even-numbered years."
 - Agreed that the entire executive board should not be up for election/re-election in the same year.
 - Section 2 [Terms of Office] amended to reflect: "Executive Board members will be elected for two-year terms. Elections for the Offices of President, Vice President of Membership and Treasurer will take place in odd numbered years. Elections for the offices of Vice President of Administration and Secretary will take place in evennumbered years."
 - Updated Bylaws to be sent with meeting minutes & updated on our website.
